Third Party Website Consent

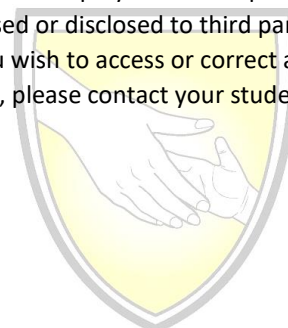

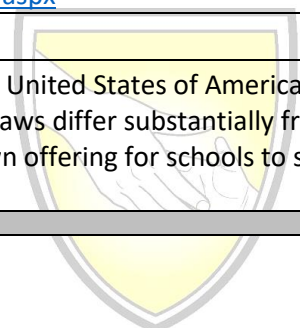
